NOTIFICATION

AMENDMENT OF THE GUIDELINES FOR IMPLEMENTATION OF CHIEF MINISTER AROGYA ARUNACHAL YOJANA (CMAAY)

Whereas, the guidelines for implementation of Chief Minister Arogya Arunachal Yojana (CMAAY) issued vide No. CMAAY/2020/196 dated 05 March 2021, Section 25 (vi) states that to encourage private hospitals to be empanelled and to ensure that appropriate and consistent quality services are delivered to the beneficiary, the State Government shall adopt package list and rates of AB-PMJAY with hike over and above PMJAY base rates as deem fit from time to time on technical justification & approval from competent authorities.

Whereas many of the private hospitals targeted for empanelment under CMAAY have not accepted package system. The absence of these high in demand private hospitals among the empaneled network hospitals have defeated the objective of the scheme to reduce the financial hardship on the people of the State due to disease and hospitalization.

Whereas in the interest of public service, the State Government vide notification no. CMAAY/2019/182 dated 06 July 2021 empaneled CMC Vellore, Tamil Nadu for extending medical services under CMAAY on credit basis at the rates of CMC prevailing at the time of utilization.

Now, it is necessitated to amend the guidelines for implementation of CMAAY to enable the empanelment of selected hospitals which are in demand for the public of Arunachal Pradesh with credit facility model as well as to extend benefits of ward entitlement to the State Government employees.

Therefore, following amendments are hereby made in the guidelines for implementation of Chief Minister Arogya Arunachal Yojana;

1. In **Section 2. Benefits: Cost of treatment to be borne by the State Government**

following table will be added after the last sentence.

“Entitlement of wards for State Government Employees in hospitals empaneled under CMAAY scheme shall be as follows.

Sl.No	Corresponding Basic Pay drawn by the Officer in 7 th CPC per month	Ward entitlement
1.	Up to Rs. 47,600 (Group-C) including contractual /Contingency / Ad-hoc employees)	General Ward
2.	Rs. 47,601 to Rs. 63,100 (Group-B)	Semi-Private Ward
3.	Rs. 63,101 and above (Group-A)	Private Ward

2. Following clause shall be added at **Section 24. Referral System.**

“(vii) Referral by District CMAAY Referral Board shall be mandatory to avail benefits under Credit Facility. For referral of cancer patients, Tertiary Cancer Centre (TCC), TRIHMS Naharlagun shall recommend the referral.

3. Following clauses shall be added at “**Section 25. Empanelment of network hospitals**” of the guidelines.

“(ix) To enable empanelment of selected hospital which are in demand for the public of Arunachal Pradesh under CMAAY, the Governing Body of CMAA Society shall adopt credit facility at the published/rack rates of these high demand hospitals. The credit extended to beneficiaries in a hospital empaneled under this clause will be the available sum assured under CMAAY i.e Rs. 5.00 lakhs per family per annum.

(x) The Executive Committee of the CMAA Society is empowered to empanel private hospitals at PM-JAY rates.

(xi) The Governing Body of CMAA Society is empowered to empanel private hospitals at Rack Rates.”
